Personal data that we process

Kasbergen Rentals processes your personal data because you use our services and/or because you provide it to us yourself (if you use the contact form or the booking form). Below you will find an overview of the personal data we process:

- First and last name
- E-mail address
- Phone number
- Address (not required)
- Postal code (not required)
- Place of residence (not required)
- Country
- Date of birth

Kasbergen Rentals does not use social media plugins. We also do not track IP addresses.

Special and/or sensitive personal data that we process

Kasbergen Rentals does not process special and/or sensitive personal data about you. Our website and/or service does not intend to collect data about website visitors who are younger than 16 years of age. Unless they have permission from parents or guardians. However, we cannot check whether a visitor is older than 16. We therefore recommend that parents be involved in their children's online activities to prevent data about children from being collected without parental consent. If you are convinced that we have collected personal information about a minor without this consent, please contact us at info@kasbergenrentals.com and we will delete this information.

For what purpose and on what basis do we process personal data?

Kasbergen Rentals processes your personal data for the following purposes:

- To call or email you if this is necessary to provide our services;
- To be able to send you an invoice for the services performed;
- To assess whether purchasing our services is legitimate.

How long we keep personal data

Kasbergen Rentals does not store your personal data for longer than is strictly necessary to achieve the purposes for which your data is collected. We use the following retention periods:

Retention period for emails received via the contact form:

1 month after the date of receipt - if our offer/service is not used;

Retention period of emails received via the booking form:

1 month after the date of purchase of the service - this to provide service regarding the delivered product or service.

In exceptional cases (e.g. after claim settlement) it is necessary to retain personal data for a longer period of time. In that case, the retention period is 1 month after settlement of this exceptional case.

Sharing personal data with third parties

Kasbergen Rentals only shares your personal data with third parties if this is necessary for the execution of the agreement or to comply with any legal obligation. We enter into a processing agreement with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. Kasbergen Rentals remains responsible for these processing operations.

Cookies, or similar techniques, that we use

Kasbergen Rentals only uses functional and technical cookies on the website. This, for example, to remember the selected language while browsing and when returning to our website.

We do not use analytical cookies and tracking cookies. You can check this by clicking on the lock in the browser.

View, adjust or delete data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent to data processing or to object to the processing of your personal data by Kasbergen Rentals and you have the right to data portability. This means that you can submit a request to us to send the personal data we have about you in a computer file to you or another organization mentioned by you.

You can send a request for access, correction, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to info@kasbergenrentals.com.

To ensure that the request for access has been made by you, we ask you to enclose a copy of your proof of identity with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN) black in this copy. This is to protect your privacy. We will respond to your request as quickly as possible, but within four weeks.

Kasbergen Rentals would also like to point out that you have the option to file a complaint with the national supervisory authority, the Dutch Data Protection Authority. Kasbergen Rentals has taken the following measures to protect your personal data:

- TLS (formerly SSL) We send your data via a secure internet connection. You can see this in the address bar 'https' and the padlock in the address bar.
- Your data is stored on a face ID-protected laptop and in a password-protected (e-mail) environment.
- Your data will be deleted after the stated retention period.
